



## FIM ENTRY CHECKLIST.

In order to compete for a world record at the BUB Motorcycle Speed Trials, advanced preparation is required. This checklist is designed to assist in the process to ensure all the appropriate paperwork is submitted. **This checklist applies to USA residents only.**

FIM entries consist of 3 parts: (a) Rider Licensing, (b) World Record Attempt Application, (c) BUB Speed Trials entry. All 3 parts must be completed in full and submitted to BUB Racing by the stated deadlines. PLEASE NOTE: The BUB Entry form is due before the FIM paperwork.

**PLEASE READ THE CHECKLIST- SOME PROCEDURES HAVE CHANGED FROM EARLIER YEARS**

- Get an FIM packet from BUB Racing Inc (includes licensing and application forms).
- READ the FIM rule book (<http://www.fim-live.com/en/fim/fim-official-documents/>)
- Complete FIM license application (a)
  - Complete *2010 FIM LICENSE APPLICATION* form
  - Sign and **notorize** the *2010 AMA ANNUAL ADULT RELEASE....etc.*
  - Complete *MEDICAL HISTORY & EXAMINATION* forms- One page **MUST** be completed by your doctor.
  - Read *FIM ANIT-DOPING CODE*. The document is available online (<http://www.fim-live.com/en/fim/fim-official-documents/>). Titled 2010 Anti-Doping Code. Sign *APPENDIX 2- Acknowledgement and Agreement by the Rider* included in packet
  - Racing resume, reference or evidence of racing experience (where applicable).
  - Make payment payable to AMA** (license fee \$50 + Insurance fee \$215 + AMA renewal if applicable).
- Complete *WORLD RECORD ATTEMPT APPLICATION* form (b)
  - Rider must sign the form- your license number will be added by the AMA.
  - Include with your application:
    - o Photos certifying the condition of the machine (2 photos with fairing and 2 without fairings), the effectiveness of the safety points (photos of each point) - see art 018.15 FIM world record rule book). Digital format preferred (CD or email). Please use hi-res 500kb or larger to ensure that the bike can be seen. All machines must provide photos- even if it has participated before in the same configuration.
- Submit both (a) forms and (b) forms to BUB Racing **NO LATER than JUNE 11<sup>th</sup> 2010**. If we do not receive it by June 11 we cannot guarantee that it will arrive at the FIM by their 2-month deadline. We will submit them to the AMA for you.
- Complete BUB Speed Trials Entry Form online. ([www.bubspeedtrials.com](http://www.bubspeedtrials.com) entry section)
  - Check FIM Box and submit BUB entry fee, payable to BUB Racing Inc.
  - Submit to BUB Racing **NO LATER than JUNE 1<sup>st</sup> 2010**.
